#### 1.2 SUBSCRIPTION :

The rate of subscription for all the members shall be Rs. 501/- payable only at the time of enrolment as a member.

1.3 CESSATION OF MEMBERSHIP :

A person shall cease be a record the society by resignation, death disquallication insolvency or liquidation or for non-attending without aking leave for absence, three consecutive multings of the General Body as the case may be.
